- i) After three attempts for ground classes / individual ground subject classes following are the charges:

Air Navigation	– Rs. 30,000.00
Air Regulation	– Rs. 20,000.00
Meteorology	– Rs. 15,000.00
Aircraft General	– Rs. 30,000.00
Aircraft Specific	- Rs. 10,000.00



- j) 100% payment to be made in case of 25H/10H/15H/15HO/PPL/PILOT LICENSE (ML) courses and in all other courses 50% at the time of admission and balance in two installments of 25% each at completion of 50 hrs and 100 hrs of flying for 190H, 190 HO, 175H and 175HO courses and at completion of 100 hrs and 150 hrs of flying for CPL courses. Go through the break-up details for each course.
- k) Hostel facility is compulsory for all students except girl students.
- l) The fee structure is applicable at the date of admission which may vary from time to time and batch to batch without any notice period due to any reason which is not in the control of the Academy like fuel prices, Government policies etc. New rates would be applicable from the date of implementation of such rates.
- m) Ground training for RTR is conducted separately for two weeks and is charged separately @ Rs 15000/-.
- n) Taxes will be applicable extra as per the prevailing Government rules.
